It is the OWNER or CONTRACTOR RESPONSIBILITY to call the Building Department (708-458-2067 x322) to schedule the following inspections:

1. **Sewer Connection** before backfill and after sewer has been tapped into sanitary sewer or storm sewers.
2. **Street Openings** before any street opening can be made.
3. **Final Inspection** for issuance of Occupancy Certificate.

Please contact the Water Department (708-458-6026) for **Water Tap Inspection** before backfill.

Any dirt from construction site must be stored on property involved. In the event that dirt is stockpiled on any other property or utility easement it will be removed at the contractor's expense.

NOTE: Fire Alarm installations require blue prints and/or diagrams and specifications for review and approval by the Building and Fire Departments prior to installation of fire alarm system. Fire alarm installations require witnessing by the Building Department or Fire Department for final approval. Call 708-458-2067 for an appointment to witness testing (24 hour notice required).
