<u>VISITOR'S COMMENTS:</u> Hugh Saurenman, ATS Consulting reviewed and discussed the study that was conducted to determine the measurements of the Belt Railway retarder noise. Conclusions could not be determined which retarders were the significant sources of noise. He would like to go into the railyard

or conduct the study again to pinpoint the exact retarders. Wind is a big factor in the measurement of noise/sound and how it travels. When the study was conducted, there were strong high winds. Jim Kennedy, EQCB chairman, stated that he has been working with the Belt Railyard for possible solutions to the noise even looking at a European company that designs equipment to reduce sound levels emitting from retarders. The prices are very high and are looking into other options. He is looking into pilot programs to find a possible solution. President Brady stated again that the inert retarders were put in place by the strong recommendation from the federal government to protect against accidents from occurring where the trains cannot stop, such accident occurred in Canada. There are no current devices that are approved by the government to lower the sound level emitting from the inert retarders. Tim Coffey, Belt Railway Co. stated that the railway has done as much as possible as they can to help in this situation. They have lowered the amount of inert retarders being installed and grants to help alleviate the expense to replace retarders. William Bowlby, Bowlby & Associates, Inc. discussed their findings and compared them to the study from ATS Consulting along with video recordings from the Village that were provided. He stated that the inerts are still an issue and the specific retarders need to be identified to reduce the noise. Mark Weglarz reiterated that the noise is an issue for their hotels and business. President Brady asked ATS Consulting and Bowlby & Associates to work together as they are professionals in their field and possible solutions to this issue in which it benefits all parties involved. No objections from parties. There will be no study conducted on Belt Railway property but they will try to assist in any other way they can.

Jill Bernal, resident of Bedford Park wanted to discuss the issue she is having with her neighbor. The issue revolves around a canine. She says she consistently has feces on her lawn or sees the canine running lose without a leash. She has communicated with her neighbor but to no avail. She finally contacted the police department which did not resolve the issue. She is asking the Village Board for help in this matter. President Brady stated he would work with the police department and contact the other resident involved.
