VILLAGE OF BEDFORD PARK, ILLINOIS

1. Time and Place of Opening Bids. Sealed proposals for the construction of the Water System Improvements, Central Avenue Pumping Station for the Village of Bedford Park, Cook County, Illinois, will be received at the Village Hall at 6701 S. Archer Road, Bedford Park, Illinois until 10:30 A.M., June 30, 2017, and at that time will be publicly opened and lump sum bid read aloud.

2. Description of Work. The proposed construction consists of providing a new pumping station building, including water piping up to 54-inch diameter, motor control center, pump motor variable frequency drives, chlorine gas equipment, heating, ventilation, and air conditioning equipment, plumbing, lighting, instrumentation and controls, site improvements and restoration, approximately 1,050 feet of 36-inch diameter water main, approximately 180 feet of 48-inch diameter water main, approximately 55 feet of 54-inch diameter suction pipe, site improvements, building demolition and restoration, installing two 250 hp vertical pumps, installing four 300 hp vertical pumps, installing an 800KW emergency generator, installing prefabricated meter vault, installing prefabricated flow control station, coordination with reservoir improvements contractor, and providing other miscellaneous items of work.

Not less than the prevailing rate of wages as determined by the Department of Labor or determined by the court on review shall be paid to all laborers, workmen and mechanics performing work under this contract.

The Village of Bedford Park is exempt from the Illinois State, municipal or county Retailers Occupation Tax, Service Occupation Tax, Use Tax, and Service Use Tax as described in Illinois Compiled Statute Chapter 35. Bid prices shall not include the cost of such taxes.

All Bids must be accompanied by a Bidder's bond, certified check, bank cashier's check or bank draft payable to the Village of Bedford Park for ten percent 10% of the total amount of the Bid as provided in the Bidder Instructions.

A **mandatory** Pre-Bid Conference of all prospective Bidders and/or their representatives will be held at the project site, 6535 S. Central Avenue, Bedford Park, Illinois 60638 on Wednesday, June 14, 2017 at 10:00 A.M. Bidders are **required** to attend and participate in the conference.
