**Vending Machine licenses are due on January 1<sup>st</sup> of each year.**

**Please Note:**

It shall be unlawful for any person to permit the installation, keeping, maintenance or use-upon his/her premises of any automatic vending machine owned or operated by a person who has not first obtained a license for each of said automatic vending machines as hereinafter provided. (Ordinance 535, 1-5-67)

Any person who violates this ordinance shall be fined not less than fifty (\$50.00) dollars nor more than one hundred (\$100.00) dollars for each offense and every such person shall be deemed guilty of a separate offense for every day during which the violation continues. (Ordinance 91-842, 6-6-91)

**Definitions:**

The phrase "amusement device" as used herein is defined to mean any mechanically operated device, the operation of which is governed or controlled by the deposit of coins or tokens, and which is played solely for the pleasure of the operator.

The phrase "juke box" as used herein is defined to mean any mechanical machine or device, the operation of which is governed or controlled by the deposit of coins or tokens, capable of producing or reproducing any vocal or instrumental sound.

The phrase "vending machine" as used herein is defined to mean any mechanical machine or device, the operation of which is governed or controlled by the deposit of coins or tokens capable automatically offering for sale of merchandise.
