Can you repeat 5 6 the numbers just so I can also keep track? MS. ALONSO: Yes. For the Seacoast? 7 VILLAGE CLERK ZAVALA: Yeah, for the totals when 8 9 you're doing it, if you don't mind doing the numbers 10 one more time so I can get --11 MS. 20	seems like they combined.

23	And then there are other bidders listed as
24	bidding; however it seems that they did not submit a

2	Concrete, but there are no bids so they either missed






